

AWARD QUALIFICATIONS

- This submission may be a joint effort by the design consulting firm and/or other key team members who played a significant role in the project such as brokers, project managers, engineers, landlords, etc.
- Evidence of positive impact on bottom line and/or improved productivity
- Unique concept
- Completed in FY2019
- The Project Team must include a CoreNet New York City Member or Sponsor in good standing
- Nominee must be located in New York City Area

- Provide project team specifics A&D Firm, End User, Broker (if a new space), Contractor and square footage
- Outline the project vision
- Demonstrate the use of innovation, design, engineering or technology practices
- Show evidence of the improvements made to the workplace (ex: cost reduction, improved productivity, employee engagement, etc.)
- Submit five photos of the project that best highlight the vision and implementation
- Provide one video walkthrough of an area you would like to highlight (max 60 seconds)
